- SSN or TIN of Owner
- Assumed Name Certificate (DBA)

### Limited Liability Company (LLC)

- Tin of LLC
- Articles of Organization
- Operating Agreement

### Partnership

- TIN of Partnership
- Partnership Agreement
- Certificate of Partnership

### Corporation

- TIN of Organization
- Articles of Incorporation

### Not-For-Profit Organization

- TIN of Organization
- If incorporated, follow corporation guidelines
- If tax exempt, IRS documentation or tax return
- If not tax exempt, authorization letter

Credit Union Membership required. Other fees such as non-sufficient funds, overdraft, sustained overdraft fees, etc. may apply. See fee schedule for details. \*10¢ per transaction for items over 1,000. \*\*50¢ per \$1,000 in cash and coin deposits over \$10,000. ^If member consistently goes over 1,000 transactions monthly, the account may be converted to Premier Business Interest Checking. ^^If member consistently goes over \$10,000 in currency deposited per month, the account may be converted to Premier Business Interest Checking. †Inactivity fee applies after six months of no activity.
